### ARTIST / WORK ELIGIBILITY

All artists over 18 years of age, residing in the United States are eligible. Work must have been completed within the last three years. NO GICLEE COPIES OF ANY KIND. Works must be ready to hang. We **cannot** accept free standing sculpture, installation, or video arts. Absolutely no substitutions of accepted works will be allowed. All accepted works must remain in the gallery for the duration of the exhibit. "Figuratively Speaking" is but not limited to the traditional/contemporary aspects of the human forms, conditions, interactions, and abstractions of the human body. "*Figuratively Speaking*" also includes *figuration in contemporary design in terms of shapes, lines, and colors.*" (Contact us for questions)

### ENTRY FEE

A non-refundable entry fee of \$35 for up to 3 works, and \$5 for an additional works. Payment may be made by check (made payable to EYA) or by secure payment with Pay Pal (EYArtists.com). \*Attention: Accepted artists from 2010 National Juried show will receive \$5 off their entry fee.\*

## **AWARDS**

**Best of Show** \$200 and A Solo show at Village Gallery (2 weeks duration).

If selected artist is unable to participate in a solo show, he or she will be given \$350 cash.

**Merit awards (3)** \$50 and a Group show at Village Gallery (2 weeks duration)

If selected artists are unable to participate in a group show, they will be given \$80 cash

## **ENTRY PROCEDURE**

**Digital Files...** must be JPEG's submitted on a CD which can be read by a PC or a MAC. JPEG images should not exceed 1600 pixels in any direction and file size cannot exceed 1 MB. Please label CD with your name and label each JPEG image as follows: LAST Name, FIRST Name, TITLE and NUMBER that corresponds with that image on the Entry Form. Failure to follow these instructions may result in the nullification of your entry.

**A signed copy of this contract** must be presented at drop off, or mailed with submission.

Please tape an identification tag to each artwork with name(s), title of piece, media, dimensions, date, and orientation. Drop off dates (in person or by a friend) are absolute, or by special arrangement. Out of town shipping is handled separately.

## **TERMS AND CONDITIONS FOR ALL PARTICIPATING ARTISTS**

- The entry fee is non-refundable in every case.
- The fee for the show is as posted. The fee remains the same for any number of works submitted by an artist no matter how many works are asked for in the call for entry. This means that if 3 artworks are asked for and 2 are sent the fee remains the same.
- EYA and Village Gallery staff takes every precaution in handling all artwork submitted by artists. EYA and Village Gallery, nor anyone associated with the gallery, shall not be held responsible for damage or loss of any artwork accepted for Figuratively Speaking Exhibition.
- All artwork must be received by the drop off/ delivery dates or the artwork may not be included in the show.
- Village Gallery take-30%-commission on all sales. EYA will take-5%-commission on all sales.
- No artwork will be removed from the gallery's premises before a show's closing date.
- Return shipping will be paid for by the artist.
- Artwork not sold, picked up, or any piece for which EYA does not receive return shipping costs will be disposed -of respectfully, but finally. EYA and Village Gallery will not be responsible for any misattributions of artwork of any kind and in all terms mentioned above. EYA and Village Gallery shall have the right to use for its purposes any image(s) of any artwork that is photographed on its premises. Artists will retain all rights in terms of attribution and ownership of any images of their making in all other respects.
