is pleased to announce its inaugural juried exhibition of photography, **LENS 2011**. Photographers are invited to submit work for possible inclusion in the exhibition. All subject matter and photographic processes are welcome.

Juror – **Natasha Egan**, Associate Director & Curator of the Museum of Contemporary Photography at Columbia College Chicago. She has organized numerous international exhibitions and contributed essays to many publications. Natasha is co-author of *The Transparent City*, a book of photographs by Michael Wolf.

Awards – One photographer will be **awarded a featured exhibition at Perspective, and a \$200 stipend**. The first runner-up will receive a \$150 stipend, and the second runner-up will receive a \$100 stipend.

Submissions – Artists are invited to submit up to five (5) photographic images, JPEG form. The images must have been created within the past five years. Artists should complete the entry form and upload their images at:

Entry Fee – The fee for submitting up to five (5) images is \$35. The fee is non-refundable.

Delivery of Accepted Work – All accepted work must be framed in a professional manner with hanging wire (no saw-tooth hangers). Work must arrive by February 23rd.

Shipping Artwork – Artists shipping artwork must use UPS or FedEx, and must include a prepaid return shipping bill. **Perspective Gallery will not be responsible for damage occurring during shipment to or from the gallery.** Work must be framed using plexiglass, not glass. Work should be shipped in sturdy reusable containers, and packed using foam sheets or bubble wrap. Do not use Styrofoam packing peanuts. Insurance of artwork during transit to and from the gallery is the responsibility of the artist. The gallery will insure all works against theft, damage, and destruction while they are at the gallery. Artwork must be shipped to:

In-Person Delivery – Artists may hand deliver work to Perspective Gallery (1310 1/2 B Chicago Ave, Evanston, IL) during normal gallery hours from 2/17-20.

Sales – Perspective Gallery will receive a 30% commission on any artwork sold during the exhibition. Artists will receive 70% of the sales price of any work sold.
