

Kentucky Arts Speaks/ K.A.S. Gallery

Eligibility

- Exhibit must be listed on the K.A.S. website. If an artist has selected to mail-in an entry, the exhibit must be written on the entry form.
- Art size no larger than 52" x 60"
- Entry must meet call to entry medium request and size requirements.

There are no membership requirements.

Conditions

- Wall-hung artwork must not exceed 90lbs and must be ready to hang on our Gallery System hanging hardware with wire attached.
- Pedestal artwork must not exceed 24" or Floor artwork must not exceed 60" in height.
- Artists must submit the art/photograph that was selected for the exhibit. No substitutions.

The K.A.S. Gallery reserves the right to refuse any work which does not match the accepted entry or does not meet the weight, hanging or display restrictions, or is deemed inappropriate. All decisions of the K.A.S Gallery are made by the owner and are final.

Entries / Images

- Entries will be juried from a projected digital image. Digital images may be mailed on CD or sent as email attachments, to enter online go to www.k-a-s-gallery.com
- Online Entries:** Emailed images should include all information requested. **Mail-in Entries:** mailed hard copy of the entry form with entry fee payment; mail-in entry must be **postmarked by submission deadline.**
- Mailed images should be on a CD with Name, phone number, mailing address and email address on label or written on CD
- All digital images files, whether on CD or email must be submitted in JPG format only, no more than 5MB each.
- File name must be in this format: firstlastname_title.jpg.

Entry Fees

No more than 5 entries may be submitted per artist

- 1 entry \$15; each additional entry is \$5.
 - Entry fees are non-refundable.**
- \$5 of an entry fee helps provide resources for the community and charitable organizations in Kentucky.

Notification of Acceptance

- Notifications will be e-mailed or mailed 30 days after the submission deadline.
- Work may be hand-delivered or shipped. Detailed instructions will be included in the notification letter. All shipping is at the expense of the exhibiting artist.

Sales

K.A.S. Gallery will add a 30% commission fee to the selling price of an art piece. Should your work sell, K.A.S. will retain a 30% commission. K.A.S. will collect sales tax from buyer and pay KY State sales tax.

Work available for purchase

It is the artist/ photographer's choice whether to sell his or her art.

Registered

Kentucky Arts Speaks/ K.A.S. Gallery is registered with Louisville County Metro Government

Liability

Every reasonable precaution will be taken during the receiving, installation, exhibition, and return of work, but no representative of the K.A.S will assume responsibility for loss or damage incurred. It is at the discretion of the Artist to carry insurance. Work should not be so fragile that shipment or public display is potentially harmful to the work or the viewer.

Agreement

Submission of digital files and accepted artwork shall constitute an agreement on the part of the artist to comply with the conditions set forth in this prospectus, including the following: No work accepted for this exhibition may be withdrawn prior to the close of the exhibition.

Permission to promote all or selected artist work in newspapers, local magazines, fliers and online to attract buyers, collectors and the public to an Art show.
